CanTEST staff provided **84** health and AOD brief interventions to people who attended and **9/76** samples tested were voluntarily discarded by people after they received their test results.

We've seen a trend in people wanting to test steroids and other oil-based drugs. Call or email CanTEST ahead of your visit to learn more about what we can or cannot test.

Ketamine

was expected in **12** samples and detected in **5**

Purities ranged from **44 - 77%**

In the samples where people expected Ketamine to be present but it wasn't found,

1 sample contained lignocaine,

2 samples contained the new psychoactive substance

2'-fluoro-2-oxo-PCE (2F-NENDCK)

and **2** samples contained **procaine** and the veterinary drug **tiletamine**.



MDMA

was expected in **20** samples and detected in **16**

Samples tested & their purity ranges consisted of:

5/8 capsules contained **23 - 79%**

4/5 powders contained **8 - 50%**

1/1 pill contained **15% (99mg)**

6/6 crystalline contained **22 - 75%**

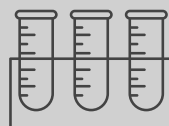
The **1** pill tested also contained **methamphetamine** & **1** powder also contained **caffeine**. In the samples where people expected **MDMA** to be present but it wasn't found, a range of other substances were detected including **dipentylone** and **cocaine (9%)**.



Cocaine

was expected in **6** samples and detected in **5**

Purities ranged from **<5 - 16%**



Heroin

was expected in **5** samples and detected in **4**

Purities ranged from **23 - 34%**

To date, no **fentanyl**s have been identified in any samples tested.



Methamphetamine

was expected in **4** samples and detected in **3**

Purities ranged from **72 - 75%**



Other Findings

A range of other substances were detected, including

α-pyrrolidinoisohexanophenone (α-PiHP),

dimethyltryptamine (DMT), isopropylphenidate,

monosodium glutamate (MSG) and

2-fluorodeschloroketamine (2-FDCK).

One unknown sample was identified as the phytoalexin **resveratrol**.

One sample presented as **benzodiazepine** was found to contain **procaine**.

To date, all of the samples presented to CanTEST which have been tested for the presence of **fentanyl**s have all returned a negative result.
