was expected and detected in **5** samples. There were no purity determinations for meth samples this month.



#### **LSD**

was expected and detected in 4 samples.

1 sample also contained





### Cocaine

was expected in 22 samples and detected in 19.

Purities ranged from 19-89%

1 sample also contained paracetamol and phenacetin.

MDMA was detected in 1 sample where cocaine was expected but it wasn't found.



was expected in 3 samples & detected in 1. 1 sample contained 2F-NENDCK, the other

dimethylpentylone.



#### **MDMA**

was expected in 39 samples and detected in 34.

Samples tested & their purity ranges:

4/5 capsules contained 30-84%

2/2 pills contained <5%

8/9 powders contained 26-82%

20/23 crystalline contained 18-84%

In addition to MDMA. 1 sample also contained dimethylpentylone.



### **Cannabis**

was expected in 2 samples and detected in **0**.

1 sample actually contained ketamine, caffeine & paracetamol



#### 2C-B

was expected in 8 samples and detected in 4.

1 sample also contained MDMA & ketamine.

> 1 sample contained 2CI.

### **Community News**

CanTEST have tested a total of 1401 samples to 20th Sept 2023.

We provided 173 health and AOD brief interventions and 10/146 samples were voluntarily discarded by people after they received their results this month.

There has been a marked increase of purity for both cocaine and **MDMA** in recent months, users should start lower and go slower than usual to avoid accidental overdose.

was expected in 4 samples and detected in 0. 3 samples contained methamphetamine, 1 sample contained lactose.



Heroin

was expected and detected in 7 samples.

Purities ranged from 23-77%.

4 samples were also found to contain 6-MAM and

1 sample also contained acetylcodeine.



Ketamine

was expected in 23 samples and detected in 20.

Purities ranged from 65-80%

1 sample also contained procaine.

In the samples where **ketamine** was expected/wasn't found:

2 contained 2F-NENDCK and 1 contained 4-MMC.
